This prima facie shows his involvement in a criminal offence on the matter relating to Dibrugarh PS Case No.936/16.

Therefore, pending initiation of departmental proceeding, the Governor of Assam is pleased to place Shri Sanjan Phukan, ACS, Asstt Commissioner, Gohpur under suspension under Rule 6(1)(C) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect and until further orders.
