ORDER BY THE GOVERNOR
NOTIFICATION

Dated Dispur, the 31st of July, 2023

No.AAP.83/2023/4: Whereas it has been informed by the Superintendent of Police-cum-Officer In-Charge, ACB PS, Directorate of Vigilance & Anti-Corruption, Assam vide their Letter No: DGVA/RC/2023/4784-A dated 24-07-2023 that Shri Biswajit Goswami, ACS, Chief Executive Officer, Zilla Parishad, Dhubri was arrested on 21.07.2023 in connection with ACB PS Case No: 53/2023, for demanding and accepting bribe money through his office staff alongwith his accomplice, Shri Mrinal Kanti Sarkar, Additional District Programmer, o/o the CEO, Dhubri Zilla Parishad and was detained in custody beyond 48 hours;

It has been further informed that, during the search of the house and official residence of Shri Biswajit Goswami, ACS, CEO, Dhubri Zilla Parishad a total amount of Rs.2,32,85,300/- (Rupees Two Crore Thirty Two Lakh Eighty Five Thousand Three Hundred) only was recovered in cash along with documents of multiple bank accounts and property related documents which were seized in presence of witnesses.

The Governor of Assam, therefore, in exercise of powers conferred under Rule 6(2) of the Assam Services (Discipline & Appeal) Rules, 1964, is pleased to order that Shri Biswajit Goswami, ACS, Chief Executive Officer, Zilla Parishad, Dhubri is deemed to have been placed under suspension with effect from the date of his arrest i.e. 21.07.2023 until further orders.

During the period of suspension, the headquarter of Shri Biswajit Goswami, ACS, if released from judicial custody, will be same as his last place of posting, subject to review if deemed necessary.
