**AAI 59/2010/90:** The following Notification No. 154/AS/2020-P.Admn. dated 23-06-2020 issued by the Election Commission of India is republished for general information :

“ In exercise of the powers conferred by sub-section (1) of section 13A of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India in consultation with the Government of Assam hereby designates Shri Nitin Kumar Shivdas Khade, IAS (AM:2004) as the Chief Electoral Officer for the State of Assam with effect from the date he takes over charge and until further orders vice Shri Mukesh C. Sahu.

2. Shri Nitin Kumar Shivdas Khade shall cease to hold and hand over forthwith the charge of all or any charges of work under the Government of Assam, which he may be holding before such assumption of office.

3. Shri Nitin Kumar Shivdas Khade while functioning as the Chief Electoral Officer, Assam shall not hold any additional charge whatsoever under the Government of Assam except that he should be designated Secretary to the Government in charge of Election Department in the State Secretariat.


