No.AAP.144/2021/11: In partial modification of this Department's earlier Notification No. AAP.144/2021/8 Dtd. 29th December, 2021, the Governor of Assam is pleased to re-engage Shri Ikramul Hussain, ACS after his superannuation on 31-12-2021 as Special Additional Secretary in the rank of Additional Secretary to the Govt. of Assam in Personnel Department and in Home Department to look after the works of Disciplinary Proceedings for a period of 8 (eight) months w.e.f. 01-01-2022 to 31-08-2022.


