No.AAP.183/2022/4: Whereas it has been informed by the Home & Political Department vide their Letter No: 241326/3 dated 30.10.2022 on the basis of the report of the Superintendent of Police, Directorate of Vigilance & Anti-Corruption, Assam vide their Letter No: DGVA/RI/2022/5594 dated 29.10.2022, that Shri Kisan Kumar Sharma, ACS, Joint Secretary to the Govt. of Assam, Home and Political Department was apprehended on 28.10.2022 while he was accepting bribe money of Rs.90,000/- (Rupees Ninety thousand only) in a trap operation launched by a team from Directorate of Vigilance & Anti-Corruption and thereafter, Shri Kisan Kumar Sharma, ACS was arrested in connection with ACB PS Case NO. 51/2022 U/S 7(a) of PC Act, 1988 on 29.10.2022 at 2.20 AM and was detained in custody beyond 48 hours;

The Governor of Assam, therefore, in exercise of powers conferred under Rule 6 (2) of the Assam Services (Discipline & Appeal) Rules, 1964, is pleased to order that Shri Kisan Kumar Sharma, ACS, Joint Secretary to the Govt. of Assam, Home and Political Department is deemed to have been placed under suspension with effect from the date of his arrest i.e. 29.10.2022 until further orders.
