No.AAP.15/2024/3: Whereas it has been informed by the Deputy Commissioner of Police (Crime) vide their Memo No. V/DCP(CRIME)/Land Record/2024/65 dated 07.02.2024 that Shri Lakshya Jyoti Das, ACS, Addl. District Commissioner, Rupahihat, Nagaon was arrested on 31.01.2024 in connection with Dispur PS Case No: 42/2024 U/S 120(B)/420/468/471/409 IPC relating to preparation of counterfeit land documents, and was detained in custody beyond 48 hours;

The Governor of Assam, therefore, in exercise of powers conferred under Rule 6(2) of the Assam Services (Discipline & Appeal) Rules, 1964, is pleased to order that Shri Lakshya Jyoti Das, ACS, Addl. District Commissioner, Rupahihat, Nagaon is deemed to have been placed under suspension from service with effect from the date of his arrest i.e. 31.01.2024 until further orders.

During the period of suspension, the headquarter of Shri Lakshya Jyoti Das, ACS, if released from custody, will be same as his last place of posting, subject to review if deemed necessary.
