No.AAP.46/2021/09: Whereas Smti Dipsikha Dey, ACS, the then Chief Executive Officer, Zilla Parishad, Cachar was transferred and posted as District Development Commissioner, Sonitpur vide No.AAA 30/2014/129-G dated 16.02.2021 as per ECI Guidelines on transfer and posting of officers for the General Election to the Assam Legislative Assembly 2021;

Whereas, Smti Dipsikha Dey, ACS handed over the charge of the CEO, Cachar Zilla Parishad knowing that she had to hand over the charge as Cachar was her home district and she cannot continue in Cachar and afterwards applied for medical leave so as to escape the task of joining at the new place of posting and also did not inform the Personnel Department in time why she did not join;

Whereas when contacted over phone, she informed to have proceeded on the leave knowing fully well the importance of key officers in districts due to election;

Whereas, the matter was referred to the Election Commission of India by the Election Department for appropriate disciplinary action against Smti Dipsikha Dey, ACS for non compliance of the transfer order vide Letter No.ELE 98/2021/102 dated 03.3.2021;

Whereas the Election Commission of India vide letter No.434/1/AS-LA/2021 dated 06.3.2021 has approved the proposal for disciplinary action against Smti Dipsikha Dey, ACS, for insubordination and negligence towards duty;

Now, therefore, pending drawal of Departmental Proceedings, Smti Dipsikha Dey, ACS, District Development Commissioner, Sonitpur (Designated), is placed under suspension under Rule 6(1) (a) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.
