No.AAP.237/2018/77: Whereas Smti Moonsoon Barkakati was recommended by the Assam Public Service Commission for appointment to the Assam Land & Revenue Service in the reserved category of Other Backward Classes on completion of the CCE-2016 vide letter No.52PSC/CON/Exam-3/2017-18 dated 16.11.2018 ;

Whereas, Smti Moonsoon Barkakati was appointed to the Assam Land and Revenue Service (Junior Grade) vide Notification No.AAP 3/2019/18 dated 09.01.2019;

Whereas, the Assam Public Service Commission vide letter No.70PSC/CON/Exam-3/2017-18 dated 17.12.2018 forwarded an allegation of submission of fake OBC certificate by Smti Moonsoon Barkakati;

Whereas the Govt of Assam, Personnel Department vide letter No.AAP 237/2018/28 dated 20.12.2018 requested the Deputy Commissioner, Jorhat to cause an enquiry and verify the authenticity/genuineness of the caste of Smti Moonsoon Barkakati. The Deputy Commissioner vide letter no.PAtoDC/JHT/18/2016/05 dated 08.01.2019 submitted a report of verification done by the Assistant Commissioner, Jorhat & CO, Jorhat East Revenue Circle with help of Sarkar Gaonburah;

Whereas the Personnel Department vide letter No.AAP 237/2018/33 dated 06.8.2019 requested the WPT&BC Deptt to examine the genuineness of the certificate by the State Level Committee for SC/ST/OBC as per procedure prescribed by the Supreme Court of India in Kumari Madhuri Patel Case so as to take further necessary action on the basis of the report;

Whereas after examination by the State Level Scrutiny Committee, the WPT&BC Deptt vide Order No.TAD/BC/380/2019/136 dated 26.02.2021 held that Smti Moonsoon Barkakati has obtained the Caste Certificate through unfair means and recommended for cancellation of the OBC certificate issued to her by the appropriate authority;

Whereas, the Deputy Commissioner, Jorhat vide No.JAP 3/2020/112 dated 01.3.2021 also cancelled the OBC certificate issued to Smti Moonsoon Barkakati on the basis of the recommendation of the WPT&BC Department;

Now, therefore, pending drawal of Departmental Proceedings, Smti Moonsoon Barkakati, ALRS, Circle Officer (A) Margherita, is placed under suspension under Rule 6(1) (a) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.
