**No.AAP.41/2023/5:** Whereas report received from the Department of School Education vide letter eCF No.221279/227 dated 18-03-2023, that Smti Sewali Devi Sharma, IAS (SCS-2010), Secretary to the Govt. of Assam, Agriculture Department opened 5 (five) nos. of Bank Accounts without approval of the Government of Assam during her tenure as the Executive Chairman cum Director, SCERT

Whereas, it has also been reported that Smti Sewali Devi Sharma, IAS (SCS-2010), Secretary to the Govt. of Assam, Agriculture Department, the then Executive Chairman cum Director, SCERT was the sole signatory and FRBM rules were not followed in respect of the above mentioned 5 (five) numbers of bank accounts; and

Whereas it has also been reported that a report of Enquiry on the functioning of ODL under SCERT found financial irregularities and very credible references of misappropriation of fund;

Whereas the Governor of Assam is satisfied that it is necessary and expedient to place Smti Sewali Devi Sharma, IAS (SCS-2010), Secretary to the Govt. of Assam, Agriculture Department under suspension from service with immediate effect;

Now therefore, pending drawal of Departmental Proceeding Smti Sewali Devi Sharma, IAS (SCS-2010), Secretary to the Govt. of Assam, Agriculture is placed under suspension under rule 3(1) of the All India Services (Discipline & Appeal) Rules, 1969 with immediate effect.

During the period of suspension, the headquarter of Smti Sewali Devi Sharma, IAS (SCS-2010) shall be Guwahati.
