NOTIFICATION

Dated Dispur, the 25th of August, 2023

No.AAP.58/2023/46: Whereas Principal Secretary, Karbi Anglong Autonomous Council, Diphu, has furnished a report to the Govt. of Assam vide Letter No: KAAC/PS/Enquiry/2016/34/108 dated 29.06.2023 of an enquiry conducted by Shri Rajeshan Terang, ACS, Secretary, Karbi Anglong Autonomous Council, into allegations lodged against Shri Mukul Kathar, ACS, the then Secretary, Karbi Anglong Autonomous Council,;

Whereas, the Secretary, Karbi Anglong Autonomous Council, stated in his report that Shri Mukul Kathar, ACS, had physically assaulted one Smti. Sengpi Teronpi and directly pointed a gun at his wife, Smti. Lindalee Teronpi and threatened to shoot her and also fired blank shots on the ground on 22.04.2023 in Diphu;

Whereas, 2 (two) cases have been registered in Diphu Police Station against Shri Mukul Kathar, ACS, under sections of Indian Penal Code and Arms Act, 1959 and the matter is under investigation;

Now, therefore pending drawal of Departmental Proceedings, Shri Mukul Kathar, ACS, is placed under suspension under Rule 6(1) of the Assam Services (Discipline & Appeal) Rules, 1964 with immediate effect.

Shri Mukul Kathar, ACS, has reported to the Personnel (A) Department on 12.06.2023, so the headquarter of Shri Mukul Kathar, ACS, shall be Guwahati during the period of suspension, subject to review if deemed necessary.
