No.AAP.107/2023/4: Whereas the Directorate of Vigilance & Anti-Corruption, Assam has reported vide their letter No.DGVA/RC/2023/8532 dated 17/10/2023, that Shri Dipankar Kalita, ACS, Asstt. Commissioner, Kamrup was apprehended on 16th October, 2023 immediately after accepting demanded bribe money of ₹3000 (Rupees Three Thousand) only in a trap operation launched by the officials of the Vigilance & Anti-Corruption, Assam and after getting sufficient evidences Shri Dipankar Kalita, ACS, Asstt. Commissioner, Kamrup was arrested in connection with ACB PS Case No.85/2023 U/S 7(a) of the PC Act, 1988 (as amended in 2018);

Whereas, the Superintendent of Police, Vigilance & Anti-Corruption, Assam - cum- Officer-in-Charge, ACB PS, Assam has also informed that Shri Dipankar Kalita, ACS has been produced before the court of Hon'ble Court of Special Judge, Assam, Guwahati on 17/10/2023 and taken on Police remand for a period of 4 (four) days for thorough interrogation and necessary follow up actions;

The Governor of Assam, therefore, in exercise of powers conferred under Rule 6(2) of the Assam Services (Discipline & Appeal) Rules, 1964, is pleased to order that Shri Dipankar Kalita, ACS, Asstt. Commissioner, Kamrup is deemed to have been placed under suspension from service with effect from the date of his arrest i.e. 16th October, 2023 until further orders.

During the period of suspension, the headquarters of the said Shri Dipankar Kalita, ACS, if released from custody, will be the same as his last place of posting, subject to review if deemed necessary.
